#### SURFSIDE CONDO COLLAPSE: Thriving Mind with Jewish Family Services assisting families



In response to the recent Surfside condo collapse, Thriving Mind is working with Jewish Community Services in providing emergency mental health care services to families, first responders, and community members traumatized by recent events."Our top priority is ensuring that all those impacted by this tragedy have access to the behavioral

health care services they may need during and after this tragedy," said CEO Dr.John Newcomer." Thriving Mind, along with the six other Managing Entities statewide, are here to support Floridians during their times of need."

#### **FAME's Quarterly Meeting**

Managing Entities from around the state met in person for the first time since the pandemic began over a year ago. State Rep. David Smith joined our discussion on the barriers to care and possible solutions to enhance services. State Rep. Christine Hunschofsky talked about the Behavioral Health Commission that was recently signed into law. DCF Secretary Shevaun Harris and Assistant Secretary Erica Floyd Thomas reviewed DCF's Strategic Plan and other priorities.



Immediately upon passage of HB 945 in 2020, FAME created a team of representatives from each Managing Entity to lead the development of a plan that promotes a coordinated system of care for children. The team methodically reviewed each section of HB 945 and worked with

Most recently, the focus has been on laws and standards around system-wide communication and engagement of local stakeholders. Another focus has been on sharing best practices across multisystems.




The Managing Entities were joined by Louis De La Parte Florida Mental Health Institute to review Mobile Response Team protocols for school interventions.



#### State Rep. Christine Hunschofsky

In the Spotlight

Nominated by Silvia Quintana, CEO, Broward Behavioral Health Coalition

State Representative Christine Hunschofsky is our legislator of the month for June. The freshman representative passed key pieces of legislation in her first session, including the behavioral health commission which will reevaluate Florida's mental health system of care. Hunschofsky met with the Managing Entity leadership team where she discussed her passion for quality mental health care and her vision for her next legislative session.



State Rep. Christine Hunschofsky earned a bachelor's degree in administration and philosophy from Boston University and an MBA from Babson College. After moving to Parkland, she became active in local government and community efforts. In 2016, Rep. Hunschofsky was the second woman in Parkland's history elected to be mayor and was re-elected without opposition in 2018. While mayor, Rep. Hunschofsky was appointed to co-chair the United States **Conference of Mayors Small Cities** Forum and testified before the Gun Violence Prevention Task Force of the 116th Congress. In 2019, she joined the American Food Coalition advocating for flood mitigation legislation in Washington DC and

was inducted into the Broward County Women's Hall of Fame. Rep. Hunschofsky was elected to the Florida House of Representatives for District 96 in November of 2020.

#### John Newcomer, MD President and CEO Thriving Mind South Florida

In the early hours of June 24th, the condo collapsed to the ground, entrapping over 150 individuals inside. As the Red Cross and FEMA deployed their resources to the disaster site, Thriving Mind South Florida, which routinely deploys Crisis Counseling teams during disasters, worked to fund and deploy one of its contracted mental healthcare providers, Jewish Community Services, to assist with the behavioral health needs of those effected. John W. Newcomer, M.D., serves as president and CEO of Thriving Mind South Florida, which is the safety net mental health managing entity for Miami Dade and Monroe Counties, funded by the State of Florida, Department of Children and Families, as well as other federal, state, local and private sources. Thriving Mind, with over 40 contracted



healthcare provider agencies across the region and close working relationships with the schools, the Homeless Trust, law enforcement, the courts and county and municipal leadership, has a deep understanding of local behavioral health needs and long track record of leadership in responding to mental health and substance use treatment and prevention needs that affect the community. Dr. Newcomer's extensive medical experience includes a psychiatry training at Stanford University and service as a principal investigator on grants funded by the National Institutes of Health and Substance Abuse and Mental Health Services Administration for almost 30 years. Dr. Newcomer has held leadership positions at Washington University in St. Louis, the University of Miami Miller School of Medicine, and Florida Atlantic University. In 2014 he was named to the Thomson Reuters List of Highly Cited Researchers. In the public sector, he previously served as Chair of the Medicaid Drug Utilization Review Board for the State of Missouri for 13 years, providing oversight for \$1.2 billion in pharmacy expenditures.



The Department of Children and Families is funding Thriving Mind to reimburse JCS for onsite crisis services provided to date and moving forward. Mental health services are available onsite in Surfside or by calling 2-1-1, a free, confidential helpline that connects Floridians in crisis to local community-based organizations.



## 2021 Bills signed into law

Senate Bill 96, Child Welfare by Sen. Lauren Book and House Children, Family, and Seniors Committee The bill makes a several changes relating to the child welfare system, including the intake process and reporting requirements, investigations, penalties, the confidentiality of records and reports. Further, the bill makes changes to the Department of Children and Families' duties, lead agencies and Managing Entities' duties, new programs, and establishes a Behavioral Health Commission.

SB 2006, Emergency Management by Sen. Danny Burgess The bill better equips Florida to address a pandemic or other public health emergency, prohibits requirements of COVID-19-vaccination documentation to access, enter, or receive service from businesses, governmental entities, and educational institutions, and protects Floridians from local orders that unnecessarily infringe rights or liberties in the name of addressing a purported emergency.

SB 804, Substance Abuse Services by Sen. Gayle Harrell, Rep. Mike Caruso (Sober Homes) The bill makes several changes to provisions governing the licensure and regulation of substance abuse treatment programs (service provider), including recovery residences. The bill makes it a third-degree felony to falsify information, or to withhold material facts, on an application for licensure as a substance abuse service provider. Substance abuse service providers operated directly by, or under contract with, any state agency must be licensed by the Department of Children and Families (the DCF) and are not currently subject to a penalty for falsification of information or withholding of material facts in an application for licensure.

#### SB 590, School Safety by Senator Harrell, Rep. Chip LaMarca, Rep. Christine Hunschofsky Requires schools

to contact a health care practitioner capable of initiating a Baker Act in person or via telehealth prior to a Baker Act being initiated. The mental health professional may be available to a school district either by contracts or interagency agreements with a local community behavioral health provider, a *Managing Entity*, or a local mobile response team. Alternatively, the mental health professionals may be a direct or contracted employee of the school district. Requires public and charter schools to make a reasonable attempt to notify the parents of a minor student before the student is removed from school, school transportation, or a school-sponsored activity for an involuntary mental health examination.

HB 701, Behavioral Health Care Services Coverage and Access by Rep. Cyndi Stevenson and Sen. Jason Brodeur The bill requires the Department of Financial Services (DFS) to submit a report, by January 31 2022, to the Legislature and the Governor regarding complaints received from insureds and subscribers about the adequacy of coverage and access to mental health services through their individual or group health insurance policies or health maintenance organization (HMO) contracts.

#### HB 231, Services for Veterans and Their Families by Rep. Ardian Zika and Sen. Gayle Harrell

The bill creates the Florida Veterans Care Coordination Program (program), to provide veterans and their families dedicated behavioral health care referral services, primarily for mental health and substance abuse. Through the program, a veteran may call a separate veterandedicated support line to receive assistance and support from a trained, fellow veteran. The Department of Veterans Affairs and its selected contractor shall work with Managing Entities to educate service providers about the Florida Veterans Support Line and the Florida Veterans Care Coordination Program. HB 241, Parents Bill of Rights by Reps. Cord Byrd and Erin Grall and Sen. Ray **Rodrigues** The bill establishes the Parents Bill of Rights. The bill provides that the state, its political subdivisions, any other governmental entity, or other institution may not infringe upon the fundamental rights of a parent to direct the upbringing, education, health care, and mental health of a minor child. If those entities infringe upon a parent's fundamental right, they must demonstrate that the action is reasonable and necessary to achieve a compelling state interest, and the action must be narrowly tailored and not otherwise served by less restrictive means.

## **COO Corner** Message from Paul Bebee

Hello everybody! I cannot believe the first half of the year is already over. As we look ahead to the next couple of months, I wanted to highlight an important awareness campaign that happens every July, Minority Mental Health Awareness Month. It's important to highlight minorities in the mental health space because, among other things, increased stigmas related to mental health care can cause fewer minorities to seek



support and counseling services. According to the American Psychiatric Association, racial minorities are less likely to receive mental health care than their white

counterparts. Among those with a mental illness, 48% of white Americans received mental health care compared to 31% of Black and Hispanic Americans. I am proud to work with an organization that values mental health care to minority populations and strives to eliminate barriers to care.
