NOTICE PURSUANT TO SECTION 394.90825 FLORIDA STATUTES

Florida state law Section 394.9082(4)(c), Florida Statutes, states that the Central Florida Behavioral Health Network, Inc.'s (CFBHN), board of directors must include representatives of providers of substance abuse and mental health services.

I serve as a volunteer board member on the CFBHN board of directors, as one of the representatives of providers of substance abuse and mental health services.

My volunteer service on the CFBHN board of directors fulfills CFBHN's legal requirement to have such volunteer representatives on its board of directors.

My employer Tri-County Human Services was awarded contracts with the CFBHN. These contracts awarded were reviewed and approved according to all applicable procedures and conflict of interest safeguards.

I did not use or attempt to use any influence to persuade the CFBHN to enter into such contracts. I did not participate in the preparation, review, or determination of the procurement documents or the determination of the best proposal leading to the award of such contracts.

A new law, Section 394.90825, Florida Statutes, which became law on July 1, 2021, requires that I notify CFBHN that the new law may designate the above contract as a conflict of interest. This document is such notice required by Section 394.90825, Florida Statutes.


